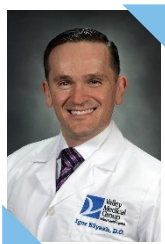

2024 General Surgery In-depth Review Seminar

PROGRAM OVERVIEW

The Program Chairs for the American College of Osteopathic Surgeons' (ACOS) 2024 General Surgery In-depth Review Seminar (IDR), Igor G. Elyash, DO, and Victoria L. Schlanser, DO, FACOS, FACS, along with the full support of the ACOS In-depth Review Committee have developed a first-rate board exam review course.

IDR sessions provide a deep dive into the topics covered in the American Osteopathic Board of Surgery (AOBS) and American Board of Medical Specialties (ABMS) General Surgery certification examinations.
